**Milan/London, 29 January 2026 – TeamSystem** – Italian **tech & AI company** leading the development of **digital platforms** for business management among companies and professionals – has acquired **AIG Classic**, a Spanish company specialised in the development of management and accounting software for SMEs, micro-businesses and professionals.

Part of TeamSystem's international growth strategy, the transaction strengthens the Group's footprint in Spain, a strategically important market given its strong similarities with the Italian entrepreneurial landscape and the central role it plays in the Group's European expansion. The Spanish market is undergoing a profound digital transformation, driven by the gradual introduction of mandatory electronic invoicing, starting with the VeriFactu system in 2027 and progressing towards widespread adoption of B2B e-invoicing by 2028. This evolution further aligns Spain with the Italian model, strengthening regulatory and technological convergence. Against this backdrop, the acquisition reinforces TeamSystem's positioning as a **European champion in the digitalisation of SMEs and professionals**, through targeted investments in countries with similar structures, needs and growth dynamics within their productive ecosystems.

Founded in **1994 in Vigo, Galicia**, in **2025** AIG Classic reported **revenues of over €5.5 million** and serves **more than 34,000 customers**, supported by a team of approximately **55 employees**. Over the years, the company has developed solutions tailored to the operational and regulatory needs of small and micro-businesses, building a broad and loyal customer base in the Iberian market. AIG Classic's offering is centred on two main products: **ClassicGes**, a business management solution covering the entire value chain of a company, and **ClassicConta**, focused on accounting and financial processes, with tools designed to simplify tax compliance and reporting.

"AIG Classic is a well-established technology company with deep knowledge of the market and the needs of SMEs and professionals.
